Are Personalised days being introduced for all Professional Level subjects for the March 2019 sitting?

FAR, AA and TC will include Personalised days for the March 2019 sitting. FM, BST and BP subjects will remain fully classroom for the March 2019 sitting with Personalised days being introduced as from the June 2019 sitting.

This phased introduction will maximise continuity of study pathway for our students.
