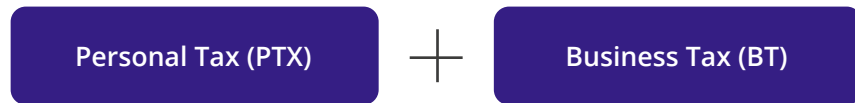

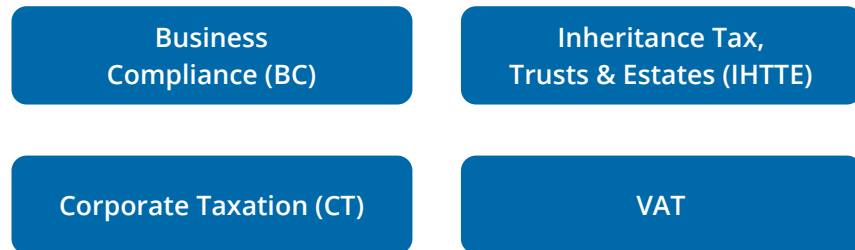

# ATT Syllabus Structure

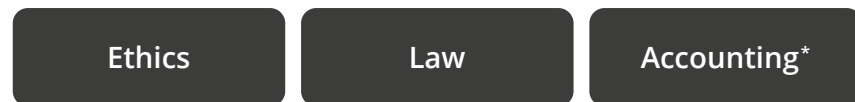
In order to complete the ATT qualification, you must pass both of the core Certificate papers.



Plus one of the optional Certificate papers, from a choice of four:



Plus three Computer Based Exams (CBE):



\*ATT students will be exempt from the Accounting CBE where they have a valid credit in the previous P2 BTAP paper or where they are qualified with a main UK accountancy body (AAT, ACCA, CIMA, CIPFA, ICAEW or ICAS).
