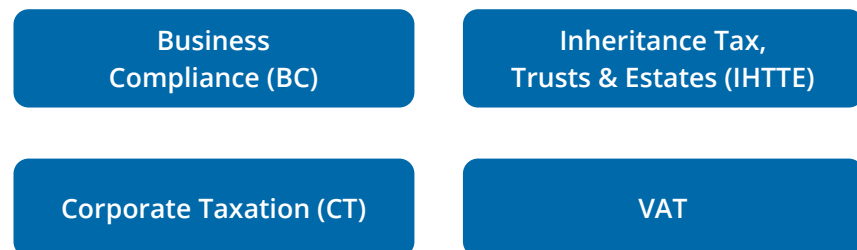

# ATT Syllabus Structure

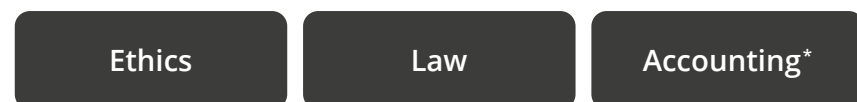
In order to complete the ATT qualification, you must pass both of the core Certificate papers.

Plus three Computer Based Exams (CBE):



\*ATT students will be exempt from the Accounting CBE where they are qualified with a main UK accountancy body (AAT, ACCA, CIMA, CIPFA, ICAEW or ICAS).

- We recommend that learners sit BT before the BC or CT option paper.
