*Students will be exempt from the Awareness paper where they are ATT exam qualified, or are exam qualified with ICAEW, ICAS, ICAI (must have passed Northern Ireland tax paper) or ACCA (must have passed P6) ** Students will be exempt from the Accounting CBE where they are qualified with a main UK Accountancy body (AAT, ACCA, CIMA, CIPFA, ICAEW or ICAS). Students will be exempt from the CBEs if sat as part of their ATT studies (valid for 9 sittings). *** Human Capital papers are run as complete courses (Tuition & Revision) at Tolley's premises for Kaplan students. We can book students onto these papers but they will receive their joining instructions & materials from and attend classes at Tolleys. Please check the timetable before enrolling, as not all courses/pathways are available in all locations to each exam sitting (May and November each year).
